# 4. STAFF RECOMMENDATION: Lost Creek Country Club No. 1 Final Plat

Mr. Haunhorst introduced the Lost Creek Country Club Final Plat. The project had been presented approximately six months ago, but was shelved due to some fire safety concerns that have since been addressed. The project includes 15 lots, that the developer has stated would match the surrounding neighborhood. There are some outstanding drainage concerns and an outstanding maintenance bond. At this time the staff is recommending conditional approval of the project.

### Motion 17 (3-26-24) DCC

Mr. Cox made the motion to accept the staff recommendation of conditional approval of the Lost Creek Country Club No. 1 Final Plat. Seconded by Mr. Ewing; the motion then went to discussion and comments.

Mr. Cox asked about the drainage problems. Mr. Bacon of Bacon & Associates said that it involved a trash grate on a catch basin. He would discuss the concerns with Mr. Gearing again, but believes that the issue has been addressed.
